# Dame Christine Lenehan appointed as IMPOWER advisor

Dame Christine Lenehan, Director of the Council for Disabled Children at the National Children's Bureau, has joined IMPOWER as an advisor.

Christine has spent the last 40 years advocating for disabled children, young people and their families. After beginning her career as a social worker, she worked extensively in both residential and community settings. She joined the Council for Disabled Children in 2000 and became Director in 2003.

Dame Christine has carried out Reviews for both the Department of Health and Department for Education. She was awarded an OBE in 2009, made an Honorary Fellow of the Royal College of Paediatrics and Child Health in 2013, and was awarded a damehood in the 2016 Queen's Birthday Honours List.
